

## **TERMS AND CONDITIONS OF ENTRY/PARTICIPATION: NATIONAL E-MOBILITY EXPO 2025 AT THE KIIRA VEHICLE PLANT, JINJA**

### **1. Introduction**

This document outlines the Terms and Conditions of entry for the National E-Mobility Expo 2025 (the “Expo”), hosted by Kiira Motors Corporation in partnership with the Secretariat for Science, Technology, and Innovation, Office of the President (STI-OP), the Government Citizens Interaction Centre (GCIC), and the Presidential CEO Forum (PCF) at the. These terms are designed to ensure the safety, security, and enjoyment of all participants at the Expo, which will be held on 18<sup>th</sup> and 19<sup>th</sup> September 2025 at the Kiira Vehicle Plant in Jinja, Uganda.

By entering/participating in the Expo, you (the “Attendee”) agree to be bound by the following terms and conditions.

### **2. General Rules of Entry**

- 2.1. All attendees must have a valid invitation. Entry is subject to the verification of the invitation and is at the discretion of the security and event staff.
- 2.2. The Expo is a private event held on private property. The organizers reserve the right to refuse entry or remove any person for any reason, including disorderly conduct or non-compliance with these terms.
- 2.3. Attendees must be at least 18 years old to attend without a parent or guardian. Attendees under 18 must be accompanied by a parent or legal guardian at all times.
- 2.4. The use of drones or any unauthorized aerial vehicles is strictly prohibited.
- 2.5. No outside food or drinks are allowed unless for medical reasons.
- 2.6. Attendees must not bring any dangerous items, including but not limited to weapons, sharp objects, illegal substances, alcohol, large bags/luggage, professional recording equipment (other than personal mobile phones), drones, or any political or promotional materials.
- 2.7. Attendees must not bring any dangerous items, including but not limited to weapons, sharp objects, or illegal substances.

### **3. Data Protection and Privacy**

In accordance with the Data Protection and Privacy Act, Cap 97, any personal information collected during the participation in the Expo will be handled responsibly and used solely for purposes related to the organization and administration of the event. The organizers are committed to safeguarding your personal data and will not share it with third parties without your consent, unless required by law.

### **4. Safety and Conduct**

- 4.1. **Plant Tours:** All attendees participating in the guided tour of the Kiira Vehicle Plant must remain with the designated group and follow all instructions from the tour guides and staff. Attendees are not permitted to enter any unauthorized or restricted areas.

- 4.2.**Vehicle Test Drives:** Participation in any test drives of electric vehicles or electric bikes is entirely at the attendee's own risk. All participants must hold a valid driver's license (for vehicles), be of legal driving age, and follow all instructions from staff.
- 4.3.**Liability Waiver:** By attending the Expo, you acknowledge that you are voluntarily participating and assume all risks of injury, loss, or damage to person or property. The event organizers, and their affiliates, employees, or agents, will not be held liable for any such injuries, losses, or damages.
- 4.4.**Personal Property:** Attendees are responsible for their personal belongings. The organizers are not liable for any loss, theft, or damage to personal property.
- 4.5.**Emergency Procedures:** In the event of an emergency, attendees must follow all instructions from event staff, security personnel, or emergency services. First aid will be available on-site.
- 4.6.**Prohibited Areas:** For your safety, do not enter any restricted or marked-off areas. These are typically active manufacturing or demonstration zones.
- 4.7.**Public Health Measures:** All attendees are required to comply with any and all health and safety guidelines, protocols, or mandates issued by the event organizers or relevant public health authorities that are in effect at the time of the Expo.
- 4.8.**Code of Conduct:** All attendees are expected to conduct themselves respectfully and professionally throughout the Expo. Harassment, discrimination, or any form of abusive behaviour towards fellow attendees, staff, or exhibitors will not be tolerated. The organizers reserve the right to remove anyone engaging in inappropriate conduct without further recourse. Any attendee experiencing or witnessing inappropriate conduct should report it immediately to event security or a designated staff member at the information desk.

## 5. Consent for Media Use

- 5.1.**Image and Likeness:** By entering the Expo, you grant the event organizers and their media partners the irrevocable right and permission to take photographs, video, and audio recordings of you during the event.
- 5.2.**Use of Content:** You consent to the use of your image, likeness, and voice in these photographs, videos, and recordings for marketing, promotional, and archival purposes, including but not limited to social media, websites, news reports, and future event promotions.
- 5.3.**No Compensation:** You acknowledge that you will not receive any compensation or payment for the use of your image, likeness, or voice.
- 5.4.**Opt-Out:** If you do not wish to be photographed or recorded, please inform a designated photographer or event staff member at the time. While reasonable efforts will be made to honour opt-out requests, attendees acknowledge that in group or public settings, complete exclusion cannot be guaranteed.

## 6. Indemnification

By entering the Expo, you agree to indemnify, defend, and hold harmless the event organizers, including Kiira Motors Corporation, and their affiliates, officers, directors, employees, and agents from and against any and all claims, liabilities, damages, losses, or expenses, including legal fees, arising out of or in any way connected with your attendance at the Expo, including but not limited to any breach of these Terms and Conditions by you.

## 7. Force Majeure

The event organizers are not liable for any failure or delay in performing their obligations under these Terms and Conditions if such failure or delay is caused by circumstances beyond their reasonable control, including but not limited to acts of God, war, terrorism, government action, fire, flood, strike, or any other event of force majeure. In such an event, the organizers may, at their discretion, reschedule, cancel, or modify the Expo without liability for any damages.

## **8. Governing Law and Dispute Resolution**

**8.1.Governing Law:** These Terms and Conditions shall be governed by and construed in accordance with the laws of the Republic of Uganda.

**8.2.Dispute Resolution:** Any dispute arising out of or in connection with these Terms and Conditions shall first be attempted to be resolved amicably between the parties. If an amicable resolution cannot be reached within a reasonable period, the dispute shall be referred to and finally resolved by the courts of Uganda.

## **9. Miscellaneous**

**9.1.Severability:** If any provision of these Terms and Conditions is found to be invalid, illegal, or unenforceable by a court of competent jurisdiction, the remaining provisions shall continue in full force and effect. The invalid or unenforceable provision shall be modified to the minimum extent necessary to make it valid and enforceable.

**9.2.Amendments:** The event organizers reserve the right to modify these terms and conditions at any time. Any changes will be posted on the official event website at <https://www.gcic.go.ug/NEME25>
